# From the Executive Vice President

The New Year is here and I hope all had a Merry Christmas and a prosperous hunting season. With the New Year comes change and the VBA is no different than anyone else, we have change, a couple of officer changes and a few shooting rule changes. We would like to welcome Cay McManus back as the Field Vice President, Cay has held this position before so she should have no problem getting back into the routine of her job. We have a new Hunting Vice President as well, Jon Robertson is from Disputanta Va which is in Prince George County, you can try and figure out how to say the name of that town on your own, he is a member of Kingsboro Bowmen and is a Hunter Ed Master Instructor and IBEP instructor and is the Hunter Education Coordinator for Prince George County and seems to have all the skills needed for the job, he sure impressed me at the last VBA quarterly meeting with his knowledge of not only hunting but also what is going on with the VGDIF.

Now onto the shooting rule changes, first of is the change in the VBA Indoor Sectionals, in the past the archer had to shoot both days for a qualifying score but now it has changed to a one score format. The tournament is still a two day shoot and you can shoot both days if you want but your best score of the two will be the one that counts and before the last two ends were inside out X's but now that has changed to the last six ends will be inside out X's. This change was done in hopes to get more shooters to participate. Now for the Spring 3-d classic which is also changing to two day one score format, this on a three year trial basis at the end of the trial period the change can be put to a vote of the directors to make it permanent or change back to its original format. And the BIGGIE of the rules changes is at the VBA State 3-D Championships, Spring and Fall, IBO rules will be used, this includes equipment rules and shooting rules. The reasoning behind this is that at the club level most of the clubs already use IBO rules and it would be simpler to shoot the rules that most shooters are already using. Next in the rules changes comes the age structure of shooting styles, seniors has been changed to 50-59, silver senior 60-69 and master seniors 70+, this change brings the VBA age structure in line with other organizations.

## AGENDA ITEMS

### AGENDA ITEMS VOTED ON AT JANUARY MEETING:

- (4) Shooting Styles, Divisions, Section A, Pg. 12, Change to read, Senior Division, 50 and older, Silver Senior Division, 60 and older, and Master Senior, 70 years and older. This breakdown is for State level shoots and archers can only compete in one division. Any archer may compete in any younger division, if they choose. Effective, Jan., 2014. **Passed, 34-0.**
- (5) Change the 3-D rules to follow IBO Shooting Rules at State level shoots, only. Effective, Jan., 2014. **Passed, 29-5.**
- (6) By-laws, Amend Art. 10, Sect. 1, c, Pg. 3, VBA charter fees for Commercial Pro Shops will be \$50.00 per year and a 50% reduction on the cost of Flight ads. Effective, Jan., 2014. **Passed, 33-1.**
- (7) Constitution, Art. 4, Sect. 3, Pg. 2, Add the word, adult, to the sentence to read; The slate of candidates must be forwarded to each adult member of affiliated clubs. Effective, Jan., 2014. **Passed, 34-0.**

### AGENDA ITEMS FOR MARCH MEETING:

- (1) The VBA shall accept the newly revised Constitution and By-laws as amended by Feb .15, 2014, as the official documents of the organization. Effective, April, 2014.

Justification: To accept reorganization and corrections to existing documents.

- (2) Cont., Art. 10, Sect. 1, Pg. 3, Change current VBA Charter fee from \$20.00 to \$25.00. Effective, Jan.01,2015. Justification: Rates have not changed in 17 years

## From the NBEF/IBEP Director

A few years ago our guest speaker at the VBA Awards Banquet was Mr. Mark Duda, Executive Director for Responsive Management, Inc. Mr. Duda and several others had recently completed work on a report titled “The Future of Hunting and the Shooting Sports”. I personally found his presentation very revealing, and I would like to share some of the “take aways” that I use in my IBEP instruction.

First, understand that hunters are a minority in our society. The report stated that “*Between 14 million and 18 million U.S. residents participate in hunting in any given year. This represents approximately 5% of the U.S. population.*” While the report did not present data on how many residents are staunch anti-hunters, let’s say the number is roughly the same. That means that the vast majority of folks are in the middle – not a hunter, but not an anti-hunter either. They are influenced by how we look, act and behave when we hunt. Said another way, every time that you go hunting, you have the opportunity to influence that neutral population one way or the other. If you go into stores, restaurants, or other public places while hunting, be aware of how you look. While leafy camouflage is great for the woods, it can make you look like a threat to others. Certainly having blood stains on your clothing from the deer you harvested in the morning can cause anxiety and concern. Personally, I wear leafy camouflage over dark colored street clothes, and take it off when I leave the woods to avoid this situation. Also give some thought to transporting your trophy. Not everyone wants to see your gutted deer hanging off the back of your pickup, and parents with children can be particularly offended. Take time to cover them up with a tarp so they are out of sight as you drive home.

Another key point I make from the report is regarding where hunters come from. The evidence in the report is very clear – the vast majority of hunters come from hunting families. As stated in the report, “*Hunting and shooting participants is highly correlated to living in a hunting or shooting culture – being surrounded by family or friends who participate and an atmosphere where hunting and shooting are part of the culture.*” If we want our sport to survive beyond our generation, we must recruit and mentor young hunters throughout our lifetime. Not only our own children, but nephews, nieces, and even the neighbor’s son or daughter that expressed an interest in going hunting. This is especially true in light of the fact that our numbers are declining. “*Hunting participation as measured in absolute numbers as well as a percentage of the U.S. population is declining in the U.S.*” So the most important trophy you take next year may not even be yours at all...but rather the one the young hunter you took with you harvested and set them on a path of being a lifetime hunter. Share the passion!

Thinking of archery hunting Alaska, Montana or Quebec? If so, you must successfully complete the International Bowhunter Education Program (IBEP) course! The course is designed to provide bowhunters with the fundamentals of good, safe bowhunting while maintaining the highest ethical standards in the sport. It instills a responsible attitude to adopt and follow acceptable behavior towards people, wildlife and the environment in which they hunt. It is also required in order to purchase an archery license in 14 states and most of the Canadian provinces!

For the second year, the Bowhunters of Rockingham is sponsoring an International Bowhunter Education Program (IBEP) class in conjunction with the VBA Awards Banquet. The IBEP instruction will be held at their clubhouse located at 3809 Longbow Road, Keezletown, VA 22832 on Saturday, 22 March 2014. The class will begin at 8:00 AM, and last until 4:00 PM. There is no cost for this class. This class is open to anyone interested in learning more about bowhunting and safety. It includes both experienced archers and novices. Young adults are welcomed and encouraged to attend, but must be at least 11 years old to enroll in a course. There is no maximum age for enrollment. Parents are encouraged to attend the course with their children.

## LEGISLATION UPDATE

Hello All,

Wanted to give an update on the rest of the legislation discussed at January meeting. To begin, I spoke with Mr. Curtis Colgate on Wednesday the 22nd after the vote on HB1237. He stated the Game Department Board was opposed to both HJ26 and SJ36, which concerns combining the DGIF with the Virginia State Police. I also, attended the Game Department board meeting on Tuesday the 28th. I addressed the board and stated the VBA's position on HB1237, SB154, HJ26 and SJ36.

SJ36 has been passed over for the year. HJ26 is still active but I have been told by a representative of the Game Department Board that HJ26 should be carried over to 2015 also.

There is HB715 that combine the Archery license and Crossbow license into one Archery license. The Game Board does not oppose this action and feels it will become law. It has passed in the House and has moved on the Senate Agriculture, Conservation and Resource committee. The Board believes it will lessen confusion of the licensing process for hunters during the archery season.

Another bill of interest is HB857, now HB857H1. It will require blaze orange to be worn during muzzleloader season when not physically in a treestand or stationary blind. There is an exception for Archery as long as it is an area where the discharge of a firearm is prohibited. Most of us do not fall under this exception. I expressed my concerns for this bill to the Game Board. I was told it would exempt bowhunters but the wording of the bill says other wise.



## Wally and Winnies' Venison Soup

- 2 pounds venison
- 2 large onions
- 1 clove garlic, minced
- 1 18 oz. can tomato juice
- 1 28 oz. can whole tomatoes, mashed
- 1 17 oz. can corn
- 1 4 oz. can chopped green chiles
- 1 cup water
- 1 10 3/4 oz. can beef broth
- 2 tsp. chili powder
- 2 small zucchini, sliced
- 2 tbsp margarine

Brown meat, onions and garlic in margarine in a large pot. Add contents of cans of tomatoes, tomato juice, corn, chilies and broth. Add water and chile powder. Cover and bring to a boil. Simmer for one hour. Add zucchini and simmer for 10 minutes.

When the deer herd is leaving the fields early you have to be in your stand early. ## **ORDER OF THE GOLDEN FEATHER**

### ***NOMINATIONS DUE IN MARCH***

The VBA Order of the Golden Feather was created to honor those persons who have given unselfishly of their time and talents toward the betterment of archery and archers. Recipients are persons who possess the virtues of sportsmanship, character, morals, integrity and friendship. As a reflection of the substance for membership, only 80 people have been elected to the Order in the past 71 years.

To be qualified, a candidate must be member in good standing of the VBA at the time of nomination, must have a minimum of ten successive years' membership in the VBA and must be sponsored by three VBA members of good standing or by a VBA Club.

This article is a reminder that candidates must be submitted to the Board of Directors at the March meeting for this year. Nominations must be in writing and be signed by sponsoring individuals or a Club office. Successful nominees have always performed duties or had an impact outside their immediate club.
